24	69,370 Bitcoin (BTC), Bitcoin Gold (BTG), Bitcoin SV (BSV), and Bitcoin Cash (BCH) seized from

26	The United States filed an amended complaint on November 20, 2020. Docket No. 8. Five parties

LLC (collectively "Battle Born"). In addition, two parties sought to intervene: Adesijuola Ogunjobi and
 Nobuaki Kobayashi. All but one of the parties were dismissed or withdrew. *See* Docket No. 19
 (Ogunjobi denial); Docket 48 (Bradberry withdrawal); Docket No. 105 (Hossain, Battle Born, Matusko,
 and Kobayashi dismissals), and Docket No. 122 (Buckley dismissal). The only remaining party, Ross
 William Ulbricht, entered into a settlement agreement stipulating to the forfeiture of the Defendant
 Bitcoins. Docket No. 47.

7 THEREFORE, based on the settlement agreement, the entire record of the case, and good cause
8 appearing, IT IS HEREBY:

9 ORDERED, ADJUDGED AND DECREED that a judgment be and hereby is
10 entered for the United States against the Defendant Bitcoins; and it is

FURTHER ORDERED, ADJUDGED AND DECREED that the Defendant Bitcoins be and
hereby are forfeited to the United States, pursuant to 18 U.S.C. §§ 981(a)(1)(A), 981(a)(1)(C), 981(b),
and 21 U.S.C. § 881(a)(6), and that all right, title and interest in said property be and hereby is vested in
the United States of America; and it is

15 FURTHER ORDERED that the United States shall dispose of the forfeited defendant property
16 according to law.

IT IS SO ORDERED.
