**INDICTMENT**

The Grand Jury charges that:

**COUNT ONE**

On or about January 6, 2021, within the District of Columbia, **AIDEN HENRY BILYARD**, committed and attempted to commit an act to obstruct, impede, and interfere with a law enforcement officer, that is, an officer from the Metropolitan Police Department, lawfully engaged in the lawful performance of his/her official duties incident to and during the commission of a civil disorder, and the civil disorder obstructed, delayed, and adversely affected commerce and the movement of any article and commodity in commerce and the conduct and performance of any federally protected function.

**(Civil Disorder, in violation of Title 18, United States Code, Section 231(a)(3))**

**COUNT TWO**

On or about January 6, 2021, within the District of Columbia, **AIDEN HENRY BILYARD**, using a deadly and dangerous weapon, that is, a chemical agent commonly known as “pepper gel,” attempted to and did forcibly assault, resist, oppose, impede, intimidate, and interfere with, an officer and employee of the United States, and of any branch of the United States Government (including any member of the uniformed services), that is, an officer from the Metropolitan Police Department, while such person was engaged in or on account of the performance of official duties, and where the acts in violation of this section involve the intent to commit another felony.

**(Assaulting, Resisting, or Impeding Certain Officers Using a Deadly and Dangerous Weapon, in violation of Title 18, United States Code, Sections 111(a)(1) and (b))**

**COUNT THREE**

On or about January 6, 2021, in the District of Columbia, **AIDEN HENRY BILYARD**, did knowingly enter and remain in a restricted building and grounds, that is, any posted, cordoned-off, and otherwise restricted area within the United States Capitol and its grounds, where the Vice President was temporarily visiting, without lawful authority to do so, and during and in relation to the offense, did use and carry a deadly and dangerous weapon, that is, a chemical agent commonly known as “pepper gel.”

**(Entering and Remaining in a Restricted Building or Grounds with a Deadly and Dangerous Weapon**, in violation of Title 18, United States Code, Section 1752(a)(1) and (b)(1)(A))

**COUNT FOUR**

On or about January 6, 2021, in the District of Columbia, **AIDEN HENRY BILYARD**, did knowingly, and with intent to impede and disrupt the orderly conduct of Government business and official functions, engage in disorderly and disruptive conduct in and within such proximity to, a restricted building and grounds, that is, any posted, cordoned-off, and otherwise restricted area within the United States Capitol and its grounds, where the Vice President was temporarily visiting, when and so that such conduct did in fact impede and disrupt the orderly conduct of Government business and official functions, and, during and in relation to the offense, did use and carry a deadly and dangerous weapon, that is, a chemical agent commonly known as “pepper gel.”

**(Disorderly and Disruptive Conduct in a Restricted Building or Grounds with a Deadly and Dangerous Weapon**, in violation of Title 18, United States Code, Section 1752(a)(2) and (b)(1)(A))

**COUNT FIVE**

On or about January 6, 2021, within the District of Columbia, **AIDEN HENRY BILYARD** did knowingly, engage in any act of physical violence against any person and property

in a restricted building and grounds, that is, any posted, cordoned-off, and otherwise restricted area within the United States Capitol and its grounds, where the Vice President was temporarily visiting and, during and in relation to the offense, did use and carry a deadly and dangerous weapon, that is, a chemical agent commonly known as “pepper gel.”

**(Engaging in Physical Violence in a Restricted Building or Grounds with a Deadly and Dangerous Weapon, in violation of Title 18, United States Code, Section 1752(a)(4) and (b)(1)(A))**

**COUNT SIX**

On or about January 6, 2021, in the District of Columbia, **AIDEN HENRY BILYARD**, willfully and knowingly engaged in disorderly and disruptive conduct within the United States Capitol Grounds or in any of the Capitol Buildings, and with the intent to impede, disrupt, and disturb the orderly conduct of a session of Congress and either House of Congress, and the orderly conduct in that building of a hearing before or any deliberation of, a committee of Congress or either House of Congress.

**(Disorderly Conduct in a Capitol Building, in violation of Title 40, United States Code, Section 5104(e)(2)(D))**

**COUNT SEVEN**

On or about January 6, 2021, within the District of Columbia, **AIDEN HENRY BILYARD** willfully and knowingly engaged in an act of physical violence within the United States Capitol Grounds and any of the Capitol Buildings.

**(Act of Physical Violence in the Capitol Grounds or Buildings, in violation of Title 40, United States Code, Section 5104(e)(2)(F))**

**COUNT EIGHT**

On or about January 6, 2021, within the District of Columbia, **AIDEN HENRY BILYARD**, did willfully injure and commit depredation, and attempted to do so, and did aid and

abet others known and unknown to do so, against property of the United States, and of any department and agency thereof, and any property which has been and is being manufactured and constructed for the United States, and any department or agency thereof, that is, a window at the United States Capitol located outside Senate Terrace Room 2 Mezzanine, causing damage in an amount more than \$1,000.

**(Destruction of Government Property and Aiding and Abetting, in violation of Title 18, United States Codes, Sections 1361 and 2)**


**COUNT NINE**

On or about January 6, 2021, in the District of Columbia, **AIDEN HENRY BILYARD**, willfully and knowingly paraded, demonstrated, and picketed in any United States Capitol Building.

**(Parading, Demonstrating, or Picketing in a Capitol Building, in violation of Title 40, United States Code, Section 5104(e)(2)(G))**
