**NOTICE OF SUPPLEMENTAL AUTHORITY**

Plaintiff files this Notice to apprise the Court of two new pieces of evidence that came to light last night. First, yesterday evening, in response to reporter questions regarding the Kennedy Center project, President Trump stated,

for the Trump administration, for me, to get involved, and to take on long term, and to carry it, or to raise money to carry it, I think that the Trump administration should certainly have recognition. Because frankly, if we don't do that, it's going to close, it will end up being ripped down.<sup>1</sup>

Separately, a photo has been circulated on social media depicting President Trump reading a placard on Air Force One that appears to read "Kennedy Center DEMOLISHED."<sup>2</sup> A copy of the photo is included below.

Given the emergency nature of this matter and Defendants' 10 a.m. filing deadline for their response to Plaintiff's motion, Plaintiff wanted to make sure the Court and Defendants are aware of this new information.
